Dentists in the UK may undertake work under the National Health Service or privately. They may opt for either of these alternatives or both. A small number of dentists are employed by the NHS but the vast majority are in private practice.



All dentists who wish to practice dentistry in the United Kingdom have to be registered with the General Dental Council (GDC)

The GDC is the 'competent authority' and maintains the register of dentists, the dental care professionals register, and the specialist lists.

The main dental organization for dentists in the UK is the <u>British Dental Association</u> (or BDA).

To register as a dentist in the UK, a qualified practitioner must present evidence of their recognized first qualification in an EU/EEA dental school, a certificate of current professional status from their current registering body (if the qualification was outside the UK), a passport and a statement attesting to their good health.

EU nationals with non-EU degrees have the option of GDC assessment, in which their qualifications, skills, knowledge, and experience are compared to that of a UK dentist at graduation. If the GDC feels that there is a lack in any area of this assessment of the candidate's equivalence, he/she may be asked to undergo additional training. In most cases, dentists in this situation will be required to sit the Overseas Registration Examination (ORE).

SPECIALTY TRAINING

The training for all specialties takes place in recognized hospital training posts is supervised by the Medical Royal Colleges and lasts from 3 to 5 years, following a minimum period of two years of postgraduate training (which includes the year of VT/DFT). So, depending upon the specialty, it may take 5 to post-graduation to become recognized specialist.

administers The GDC lists registered dentists who meet certain conditions and have been given the right by the GDC to use a specialist title. Two dental specialties, Oral Surgery and Orthodontics, recognized by the EU but UK law allows the GDC to recognize any specialty where this would be justified in the interests of the public and the dental profession. The lists indicate the registered dentists who entitled to use a specialist title but do not restrict the right of any registered dentist to practice in any particular field of dentistry or the right of any specialist to practice in other fields of dentistry.

Entry requirements

You will usually need a 2:1 degree from a UK University or equivalent.

If English isn't your first language, you'll need to show evidence of your English language ability. The minimum IELTS test score for entry to a research program is 6.5 overall, with at least 5.5 in each element of the test. However, postgraduate research programs are linguistically more demanding, and higher command of the English language and/or higher IELTS scores are required. This will be indicated upon advertisement of that specific research degree study opportunity, upon contact and/or following interview with the applicant.

DOCTOR OF PHILOSOPHY (PH.D.)

Entry Requirements

All applicants must meet the following criteria.

You will usually need a 2:1 degree from a UK University or equivalent. If English isn't your first language, you'll need to show evidence of your English language ability.

The minimum IELTS test score for entry to a research program is 6.5 overall, with at least 5.5 in each element of the test. However, some postgraduate research degree programs are linguistically more demanding, and higher command of the English language and/or higher IELTS scores are required. This will be indicated upon advertisement of that specific research degree study opportunity, upon contact and/or following interview with the applicant. Two satisfactory academic references.





INTRODUCTION

Portugal has a wealth of experience in providing high-quality degree programs. Many universities in Portugal offer courses that are globally competitive and known for their eligibility.

The vast majority of programs are taught in Portuguese, and some graduate programs are offered in English as well.

DENTAL UNIVERSITIES:

The country has 3 public dental schools that are located in the Universities of Coimbra, Porto and Lisbon:

University of Porto, faculty of dental medicine

University of Lisbon, Faculty of dental medicine

University of Coimbra, Faculty of medicine

and 4 private dental schools that are in the Institutes of Health (North - CESPU and South - Egas Moniz), in the Fernando Pessoa University and in the Catholic University.

Institute of Health, CESPU

Institute of health Egas Moniz

Fernando Pessoa University

Catholic University, Faculty of dental medicine

The study dentistry program lasts <u>5 years</u>.

SPECIALTY TRAINING

The Portuguese Dental Association OMD(Ordem dos Médicos Dentistas) holds exclusive and public competencies for implementing and recognizing dental specialties.

Specialist training in Portugal, in the recognised specialties of :

- Orthodontics (especialista em ortodontia)
- •Oral surgery (especialista em cirurgia oral)
- •Paediatric dentistry (especialista em ondontopediatria)
- Periodontology (especialista em periodontologia)
- •Endodontics (especialista em endodontia)
- Prosthodontics (especialista em prostodontia)
- Dental public health (dental public health)
- •Hospital dental medicine (especialista em medicina dentária hospitalar)

Specialists must register as such in a register administered by the OMD.

RECOGNITION OF ACADEMIC DEGREES AND DIPLOMAS AWARDED BY FOREIGN HIGHER EDUCATION INSTITUTIONS:

The recognition of degrees and diplomas can be carried out through the following three types of recognition:

- Automatic recognition
- Level recognition
- Specific recognition

Recognition of foreign courses in the area of Dental Sciences can be directed to one of the following national higher education institutions:

- Faculty of Dentistry of the University of Porto
- Faculty of Dentistry of the Catholic University of Portugal
- Faculty of Medicine of the University of Coimbra
- Faculty of Dentistry of the University of Lisbon



The Faculty of Dental Medicine of the University of Lisbon awards the following recognitions, within its area of training:

- •Level Recognitions (Bachelor, Master and Doctor degrees).
- •Specific Acknowledgments:
- -Degree in Basic Sciences of Oral Health
- -Integrated Master in Dental Medicine
- -PhD in Dentistry.

It is possible to apply for the Specific Recognition of the Integrated Master in Dentistry with a foreign 1st cycle degree (degree or bachelor's degree) as long as the foreign degree has 300 to 360 credits and a normal (minimum) duration of between 10 and 12 curricular semesters.

How about the knowledge assessment procedure?

- -In the case of level recognition, it is not necessary to carry out any knowledge assessment procedure.
- -In the case of specific recognition of the Degree in Basic Sciences of Oral Health, it is mandatory to take a written test to assess knowledge.
- -In the case of specific recognition of the Integrated Master in Dentistry, it is mandatory to carry out a written test to assess knowledge and to carry out a test for discussion and evaluation of the dissertation / final course work.

In order to enroll in the Portuguese Dental Association and to practice the profession of Dentist in Portugal, Specific Recognition of the Integrated Master in Dentistry is required.



To obtain registration an applicant must hold a degree or Diploma in Dentistry (Dental Medicine) issued by an institute of higher education, Portuguese or foreign. If the degree was obtained in a foreign school, it is necessary to obtain accreditation from the Portuguese Dental Association OMD. Also allowed to register are those who hold a degree from another school and obtain accreditation from OMD, according to the legal provisions in force.

The OMD Statutes define the acts that a dentist may perform as "the study, prevention, diagnosis and treatment of dental and oral diseases, jaws and annexed structures".

Registration with OMD of foreign dentists holding a degree from abroad is subject to the health coverage needs of dentists in the country and to the provisions of European law and other international agreements in force.

Migrants must have basic knowledge of Portuguese, the official language necessary for practicing the profession in Portugal. Nevertheless, this disposition needs further development in order to be completely transposed into an official control.

GERMANY

INTRODUCTION

Germany is a leader in the field of healthcare. State universities in Germany offer the finest education and training

to national and International students and most of the state universities are highly ranked across the world.

There are 30 dental schools and 29 of them are publicly funded and are part of the Colleges of Medicine of Universities. There is only one private dental school offering undergraduate training, in Witten-Herdecke. The undergraduate course lasts 5 years and 6 months.

After the successful completion of the program, students are awarded the title of Doctor of Dentistry

The main degree to be included in the register is the state examination certificate in dentistry.

In order to register as a dentist and provide care within the statutory sick fund system, a German dentist with a German state exam pass must have two years of approved supervised experience, in addition to the five and a half years of dental training at the university. A dentist can then apply to the admission committee of the Kassenzahnärztliche Vereinigungen (KZV).

Dentists from EU member countries with an EU diploma are not required to have the additional two years of experience.

There are no national regulations regarding the necessity of German language skills for non-German dentists who want to practice in Germany. Those matters are usually decided at Länder level and a number of states have introduced compulsory language tests over the last few years.



SPECIALTY TRAINING

Three dental specialties are recognized throughout Germany:

- Oral Surgery
- Orthodontics
- •Dental Public Health
- •The speciality "Periodontology" is only recognized by the dental chamber in the region Westfalen-Lippe.

The training for all specialties lasts four years and takes place in university clinics or recognized training practices, except for Dental Public Health, which is trained in its own environment.

In principle, there is no limitation in the number of trainees, because there are sufficient dentists in free practice with permission to train a dentist in orthodontics or oral surgery.

The trainee has the status of an employee and gets a salary from his or her employer that can be a dentist in free practice with special permission to train dentists, a university or a hospital.

After completion of the specialized training the trainee has to pass an examination organized under the responsibility of the dental chamber. He or she is then approved as a specialist and registered with the dental chamber as such.

PRACTICING IN GERMANY

FOREIGN DENTISTS

In principle, you as a foreign dentist are entitled to practice dentistry in Germany

If you do not intend to work in Germany for more than two years then you can apply for a permit to temporarily practice dentistry. A temporary permit to practice can only be granted upon application, which requires proof of completed dental education and training



A temporary professional permit is not needed if the dental education and training in question were completed in an EU member state, another signatory state to the European Economic Area .(EEA) or in Switzerland

In order to permanently practice as a dentist in Germany you must first apply for and be granted a German license (called 'Approbation'). This can be granted upon application if the following conditions are met

- •The dentistry education and training are equivalent to that in Germany
- •You have not been found guilty of any conduct that would render you unsuitable or unfit to practice dentistry
- •You are not unfit to practice for health reasons

You have the level of German language skills required to practice your profession.

If you have a different qualification, then its equivalency must be assessed and determined on a case-by-case basis.



REGISTRATION

To register as a dentist in Switzerland:

- -A practitioner must have a recognized diploma with a minimum of 5 years study, evidence of 2 years' additional postgraduate experience and be able to demonstrate ongoing participation in continuing education.
- -The dentist must be able to speak German, French or Italian depending on which part of Switzerland they are going to work.
- Foreign dentists with non recognized diplomas have the possibility to apply for a master's degree in dental medicine (2 years of study) at one of the four dental schools if the requirements for admission are met.

SPECIALTY TRAINING

In Switzerland there are four specialties

- Orthodontics: 4 years of training and exam
- Periodonti+cs: 3 years of training and exam
- training and exam
 •Oral surgery 3 years of training and exam
- •Prosthetics are officially recognized by the SSO.
- •Maxillofacial surgery is recognized as a medical speciality, by the Swiss Medical Association

Training is provided in dental university centers and at private specialists' practices.

Examinations and registration are organized by Schweizerische Zahnärzte-Gesellschaft, in collaboration with the Swiss federal health office.


